**PLEDGE OF ALLEGIANCE:** President Patty Greeves led the owners in the Pledge of Allegiance.

**CALL TO ORDER:** Greeves called the meeting to order at 1:00 p.m.

**DETERMINATION OF QUORUM:** Present were: President Greeves, Vice President Dick Bloss, Secretary Keith Dalton, Treasurer Lowell Kindschy, Member Kim Norwood and Member Larry Kontz. Absent (excused) was Member Jim Matteson.

A quorum was determined. About 75 Arrowhead property owners were present.

**Vote - approve Draft Financial Reports for Jan/Feb/Mar/Apr/May 2019:** Motion by Bloss, seconded by Dalton. Unanimously approved.

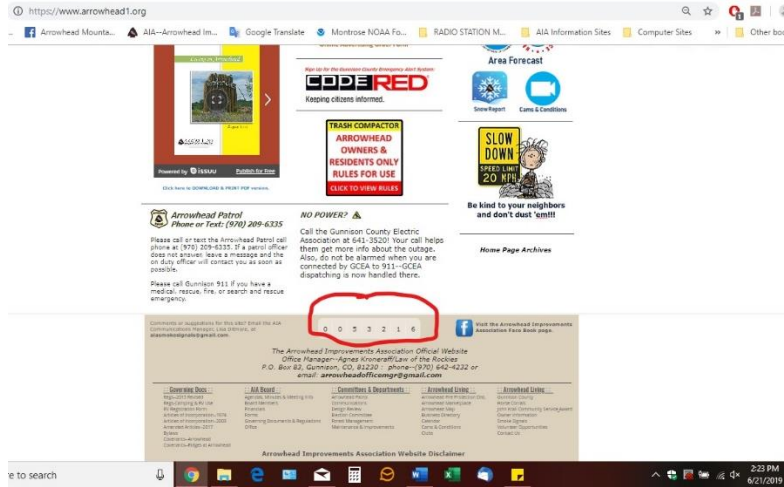

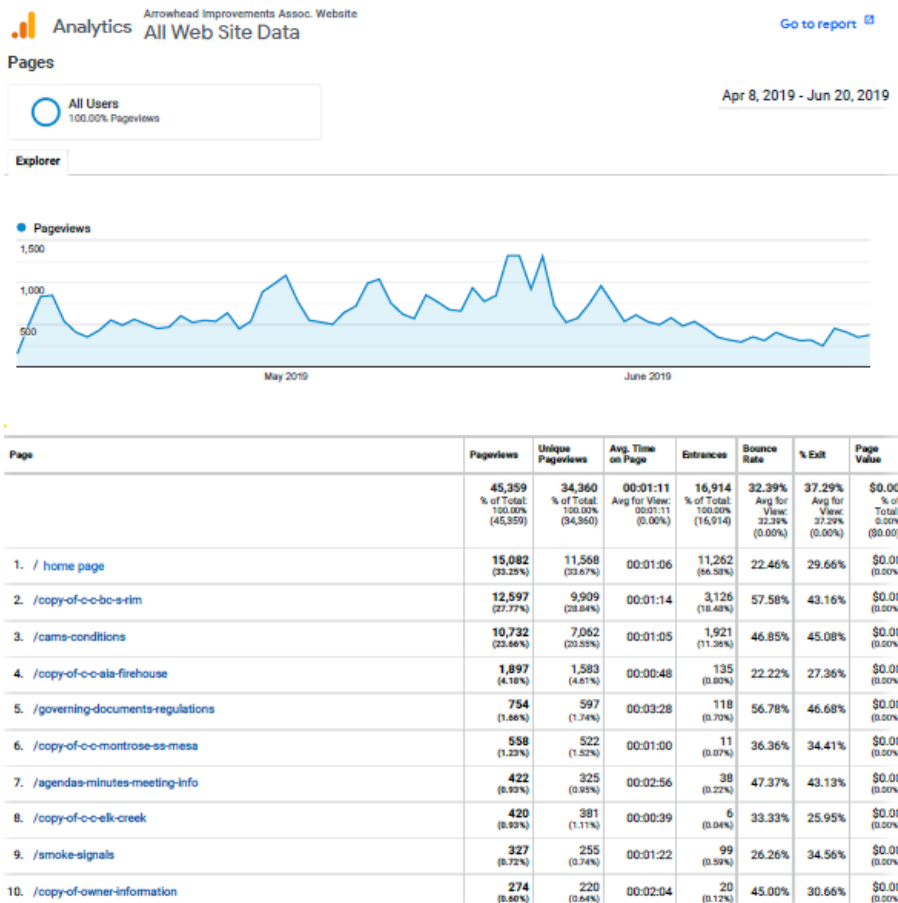
# Communications – June 2019 Report:

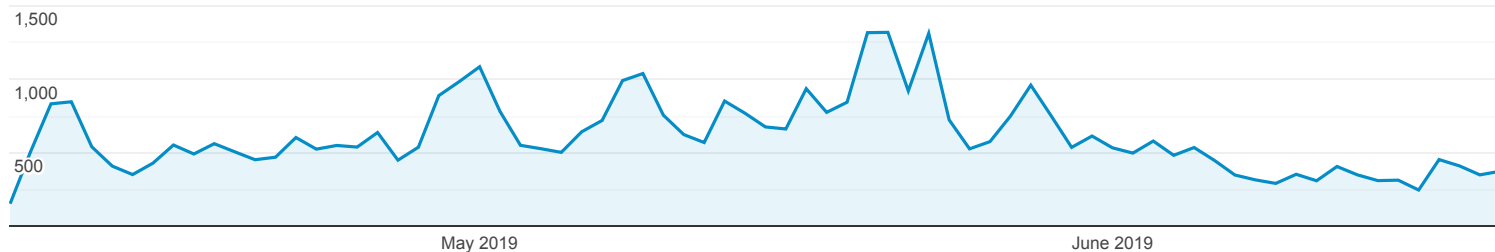
