



Our 4th of July weekend went well without any serious incidents. We had a few reports of property owners or their guests, driving too fast on their ATV's.

Fire Pits: The Gunnison County Sheriff lifted the Stage 1 fire restriction on July 23rd, 2013. We are now allowing the regular use of open fires in approved fire pits, but please keep the height of the flame to a minimum and remember safety with all fire use.


<u>Dogs-at-Large:</u> We had reports of dogs running at large and not under the owner's voice control. Folks walking on the filing roads and neighbors are scared by these dogs and be reminded, that after the first incident warning, Security will issue a fine of \$50 to dog owners breaking this rule.

<u>Fishing at the Flint Lakes:</u> Enjoy your fishing at the Flint Lakes. They were stocked with fresh fish on June 28^{th.} We're still looking for a vendor that can deliver approx. 330 pounds of additional trout to the Flint Lakes and Hazel Lake. Unfortunately, 3 out of the 4 vendors on the Western Slope are sold out for the season. I'm still waiting for a reply from one last vendor that could possibly make a delivery in August. Fishing permits can be obtained from Security.

<u>Sign-In- Boxes:</u> Sign-in boxes are at the corner of Alpine and Ute Road, and the Alpine and Lake Road. The sign-in sheets are used to let Security assist you with issuing vehicle stickers, visitor and contractor passes, requesting a reservation for using the AIA dump trailer, requesting a "new" or renewing an existing fire pit permit. If you have a second RV/Camper, you need a 14 day permit from Security for it. If you want an extension of your 14 day RV/Camper permit, you must have already petitioned the AIA Board for approval for its extension.

Now that we are in mid-summer the community is busy doing mitigation and removing danger trees. 30 permits have been issued in the last month for removal of trees dangerous to structures or parking areas. Some people have also received permits for lot mitigation. If you have any questions about mitigation or tree health, please contact me for advice and a permit to do the work.

The flight of Douglas fir beetles is starting to taper off in most parts of Arrowhead, but is still at fairly high levels along the ridge to the east of the Flint Lakes. Although there are still some significant pockets of Douglas fir mortality at Arrowhead, the primary long term concern continues to be the spruce beetle.


Large areas of spruce mortality south of Creede burned this year in the West Fork fire and that infestation is moving East / Northeast toward Los Pinos pass. The Forest Service sold a small salvage sale last week NE of Willow Park to remove blow down spruce timber that had the potential to cause a buildup of spruce beetles in that area. About 30 truckloads of logs will be hauled down the Alpine from this sale in August and September.

The larger Long Draw Timber Sale is also under contract in that area and will have several different harvest types that are intended to increase the vigor of existing spruce and to create new stands of spruce by doing ¼ acre patch cuts. The exact dates and conditions under which this sale will be logged are under discussion between the Forest Service and Arrowhead and the information will be announced at the August 17 board meeting.

These sales are intend to prevent a large build up of spruce beetles on the Alpine Plateau and at Arrowhead.

Aspen and subalpine fir (balsam) are relatively short lived trees compared to spruce and Douglas fir. Aspen and subalpine fir continue to die throughout Arrowhead from various causes. Thinning the trees on your property can sometime extend the life of subalpine fir. The cleanup day on July 27 removed about 30 dead subalpine fir and aspen from common lands along the filing road. In some cases, trees that were sound were left along the edge of the road and are available for anyone to cut for fire wood.




Design Review has been busy this summer. There are a lot of new owners that are excited to be part of Arrowhead. Stop and say hello to new owners and old owners that are just now working on their lot.

There are four houses under construction this summer. I have also discussed plans for three other houses, which will probably start next summer. Five (5) sheds have been approved for this summer. Three (3) deck additions and one remodel are also in progress. Eight (8) driveways and RV pad locations are identified. Some of the new driveways are on lots with new owners and these owners are anxious to get started on improving their lots and becoming involved with Arrowhead. I can tell by the questions, email and phone conversations those owners are reading the Regulations. One lady even quoted from my last article in the Smoke Signals.

One last thing to remember. When you put in a road or buy a lot with a road, you are responsible to put your address sign at the entrance to your lot. There are sign standards in the Regulations. The sign can be no larger than 12" by 24". Also, if your drive forks to your lot, you will need a number sign there also. You might try to incorporate reflective numbers into your sign, so it can be seen at night. Have a great summer and enjoy Arrowhead!!

The Obnoxious Noxious Weeds!!

It is the time of year that noxious weeds are sprouting up in Arrowhead. These weeds are aggressive, spread rapidly, resist, rob plants of water and deplete food for our wildlife and change the entire ecosystem. Wind, water, control and reproduce at an alarming rate. They are non-native and have invaded our environment and will dominate and crowd out native species. Noxious weeds deplete nitrogen from the soil, suffocate our native plantshorses, wildlife, vehicles, clothing and pets - all spread noxious weed seeds.

The 1996 "Colorado Noxious Weed Act" states that each property owner is responsible for managing noxious weeds on their property.

Noxious weeds identified in Arrowhead:

<u>Canada Thistle</u> - compact purple flowers, 1-5 ft. tall, stems branched at top, spiny leaves <u>Musk Thistle</u> - large compact purple flowers, 2-6 ft. tall, solitary flower on stem, spiny leaves <u>Oxeye Daisy</u> - white ray petals, yellow disk (center), wavy-edged leaves, 10-24" tall <u>Scentless Chamomile Daisy</u> - white ray petals, yellow center, fern-like leaves, 6-30" tall <u>Common Mullein</u> - stalk of yellow flowers, soft fuzzy leaves, 2-5 ft. tall <u>Yellow Toadflax</u> or "Butter & Eggs" - looks like small yellow snap dragons <u>Common Burdock</u> - numerous purple/white bur-like flowers, bushy leafy plant, 2-6 ft. tall <u>Dame's Rocket</u> - cluster of purple flowers with 4 petals, long leaves, 4 inches to 3 ft. tall Spotted Knapweed - pinkish purple blooms similar to thistles, dark spots on bracts, 1-3 ft. tall

It is almost impossible to completely dig the root of a noxious weed. Herbicides are the most effective method to control noxious weeds. To make this easier and cost effective for owners, the AIA is providing a herbicide called Curtail to property owners **free of charge.** Also, a hand sprayer or backpack sprayer can be loaned to owners to apply the spray.

If you want to schedule a time to get the herbicide and/or sprayer, please call Patty Greeves at 970-862-8388.

In addition to spraying with a herbicide, removing the head of the plant before it blooms helps to reduce the spread of the seeds. Always dispose of noxious seed heads in a double plastic bag and take them to the Montrose or Gunnison Landfill.

- DO NOT take them to the Forest Refuse Site for disposal as this will only contribute to spreading the seeds.
- DO NOT put them in the trash compactor.

Volunteers are spraying the common areas along the filing roads to help eradicate the weeds in Arrowhead.

Let's all work together to rid our community of noxious weeds and protect our native vegetation and wildlife.



Common household accidents are usually preventable with some planning and preparation. Household injuries and accidents are more common than work injuries or auto accidents. As I say that, I am still recovering from a broken knee cap that was caused by an accidental fall.

Falls, burns, drug overdose and electrical shock are four common causes of injury in the home.



Falls

First consider medical problems and medications that might cause dizziness or fainting. Prevention includes caution on stairways and removal of clutter on stairs and around stairs. Handrails should be used and on both sides of stairs. Area rugs should be kept at a minimum and taped or secured to the floor and electrical cords should be secured and not placed under rugs. Wipe up spills immediately, to keep the floor from being wet or sticky, and wear shoes with non slip soles. First aid for falls includes the steps in RICE. Rest, ice, compression and elevation. Ice should never be placed directly on the skin, use a towel between skin and ice. Leave cold compress on no more than 20 minutes at a time. Medical evaluation is needed to rule out fractures or serious injury. Check for any head injury associated with fall. Medical evaluation may be needed if there is any confusion or memory loss.

Burns

Most burns occur in the kitchen. They can be steam burns, often from microwave food, from grease burns or contact burns. Prevention includes: using proper techniques such as large pot holders, caution with food cooked in microwave and avoid long draping sleeves. Pot handles should be turned to inside to prevent accidental spills. Pots with burning grease should be smothered out with a lid. Never pick up a skillet with burning grease, as moving it may cause the heat or flames to move toward the face or body. Immediately turn off heat. Treat burns by using cool water, if the skin is not broken. To prevent infection, try to keep the skin intact and don't break blisters. Cool compresses allow temperature reduction without damaging the skin. Do not use salve, butter, or ice as they make it worse. Cover with dry bandage, later aloe vera cream may help with pain and swelling. If there is charring or white skin, it may be a third degree burn and needs immediate medical attention.

Medication

Make sure all medications, prescriptions and over the counter medications, are kept in a secure place. Use only medication prescribed for you; do **not** share medicine. Read the information that comes with the prescription and understand common reactions. If you think you have overdosed or taken a wrong medication call the pharmacy or poison control at 1-800-222-1222.

Electrical Shock

Unplug any electric appliance or device that you are not using. Remember electricity and water do not mix. If a shock causes anything more than a brief pain seek medical care. All new construction must have Groundfault circuit interrupters or GFCI on all electrical plugs near a water source. They instantly turn off electricity if an appliance overheats or comes in contact with water.

This is not a complete guide, but just intended to help with minor accidents. There are many first aid books available with more comprehensive information and care. Please seek professional medical help if you have any doubt about care or treatment.
